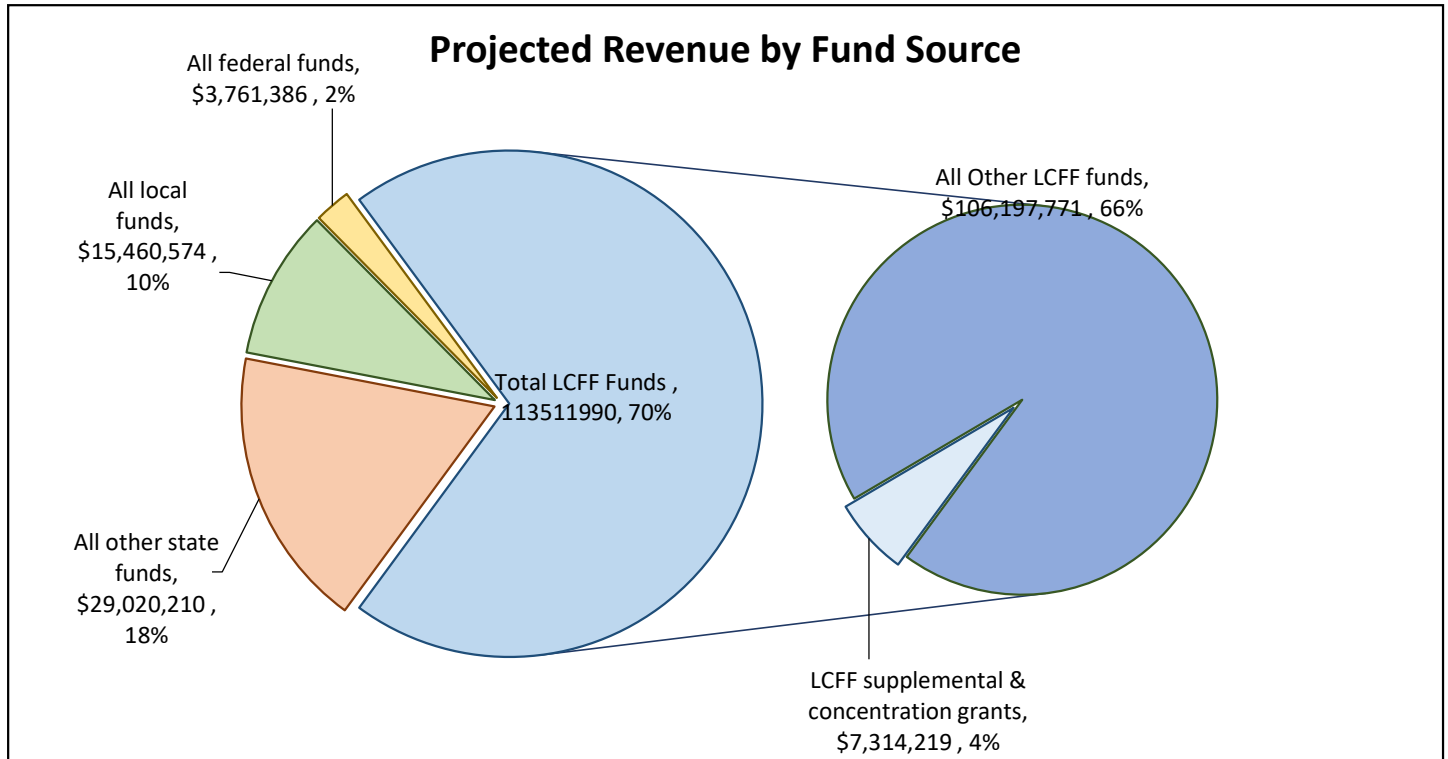

Projected Revenue by Fund Source

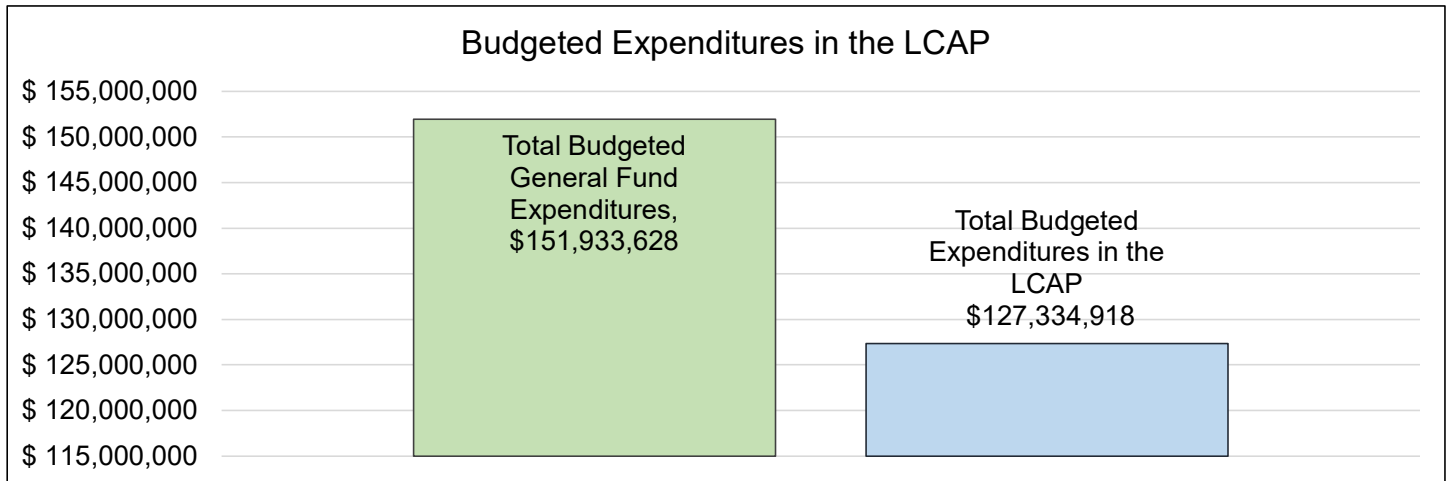


This chart shows the total general purpose revenue Saugus Union School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Saugus Union School District is \$161,754,160.00, of which \$113,511,990.00 is Local Control Funding Formula (LCFF), \$29,020,210.00 is other state funds, \$15,460,574.00 is local funds, and \$3,761,386.00 is federal funds. Of the \$113,511,990.00 in LCFF Funds, \$7,314,219.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.

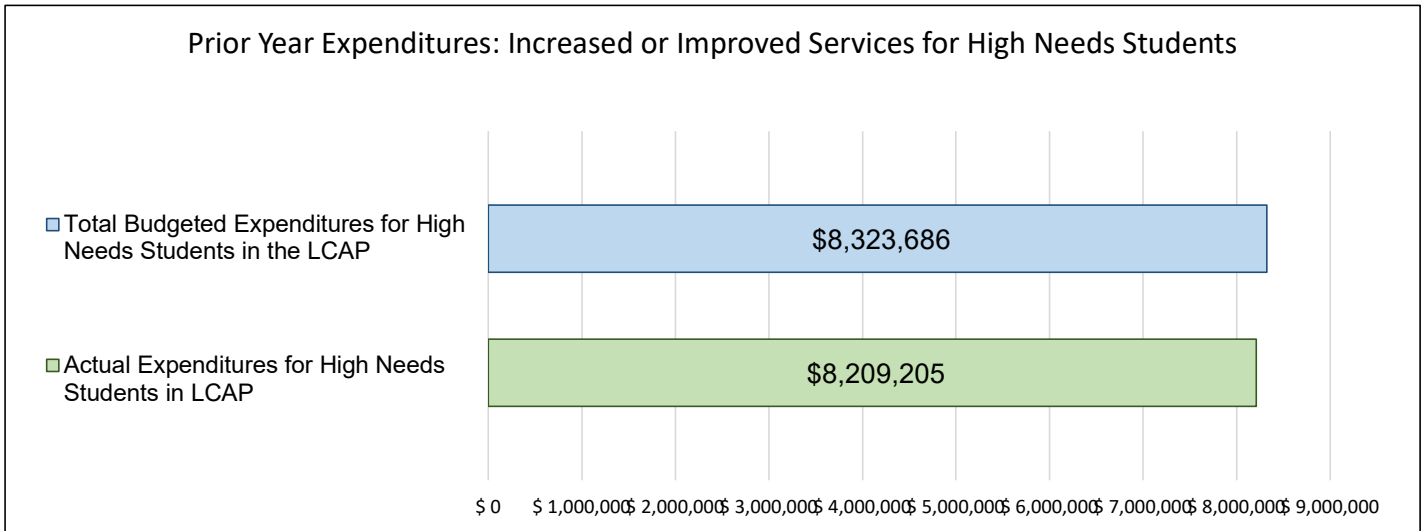
Expenditures not included in the LCAP include salaries and benefits for classified and non-teaching certificated positions at school sites, the district office, and maintenance and operations. It also includes custodial services, grounds maintenance, utilities, and various other facility expenses. Programs or services not included in the LCAP are Title 1 resources, Title 2 Professional Development and instructional practices, Title 3 programs supporting English Learners, Special Education including transportation, and After School Education and Safety (ASES) and Expanded Learning Opportunities programs.

The text description of the above chart is as follows: In FY 2025-26, Saugus Union School District's LCAP budgeted \$8,323,686.00 for planned actions to increase or improve services for high needs students. Saugus Union School District actually spent \$8,209,205.00 for actions to increase or improve services for high needs students in FY 2025-26. The difference between the budgeted and actual expenditures of \$114,481.00 had the following impact on Saugus Union School District's ability to increase or improve services for high needs students:

Actual costs of budgeted actions and services were less than anticipated due to staffing challenges, especially with classified staff. We were not able to fill all the anticipated positions throughout the year and thus could not fully expend the funds originally allocated to certain actions. SUSD adjusted processes and procedures to maintain services to high needs students.

Plan Summary 2026-2027

General Information

The Saugus Union School District (SUSD) is located in the Santa Clarita Valley (SCV) as part of Northern Los Angeles County. It is approximately 94 square miles on the west side of the valley and is one of four elementary school districts in the area. Our 14 school sites include Transitional Kindergarten through 6th grades classes and several specialized programs for students. SUSD provides the Regional Autism Program (RAP) for the Santa Clarita Valley (SCV) SELPA, provides the Special Education Preschool program for the SCV SELPA, provides the Early Start Program for the SCV SELPA and a full offering of special education classrooms and services to meet the individual education plans (IEP) of our elementary and early elementary students. SUSD also provides extensive expanded learning programs and an age three/four-year-old preschool program to support the unique needs of its families in the Valley.

SUSD is home to a diverse community with over 9,000 students and over 1,300 employees committed to serving and creating a school environment that helps students to thrive. Our school district student groups include 37.0% unduplicated students (i.e., Foster Youth (0.3%), English Learners (6.7%), and Socio-economically Disadvantaged students (35.4%)), 17.8% special education students, 1.2% Homeless students, 3.5% African American/Black students, 39.9% Hispanic/Latinx students, 9.6% Asian/Pacific Islander students, 0.3% Native American students, 8.0% Two or More Races, and 31.6% White students. The district has active parent organizations that include several PTA/PTO groups as well as 14 School Site Councils (SSC) and 14 English Learner Advisory Committees (ELAC). Parent advisory groups at the district level include the PAC (Parent Advisory Committee), DELAC (District English Learner Advisory Committee), Parent Leadership (presidents from each site-based PTA/PTO), and our Parent and Educators Advisory Council for Engagement (P.E.A.C.E.) that began in 2020. P.E.A.C.E. is designed to provide the district with assistance in creating equitable school environments that are inclusive and representative of the entire district community. SUSD strives to provide unique learning opportunities at each of its 14 school sites. This ensures that parents and students have choices that best meet their individual interests and needs. For example, Emblem Academy provides its ESTEEM program (Ethics, Science, Technology, Engineering, Entrepreneurship, and Mathematics), while Highlands Elementary School offers the district's Dual Language Immersion (DLI) program and Cedar Creek Elementary School hosts an edible schoolyard program that uses project-based learning to explore sustainable environments, food production and preparation, healthy eating habits, and business to make its core curriculum of reading, writing, math, and science come to life in the garden or kitchen. Each school is focused on providing a special learning opportunity that is relevant to 21st Century needs and to the interests of its students which allows families to make choices about their child(ren)'s education to fully engage them in learning from TK-6th grade. This approach also allows students to enter their secondary learning prepared with foundations that will allow them to explore and grow further in an area or switch to a different area of interest. Regardless of the special emphasis, each of the 14 schools in SUSD provide a rigorous, standards-based program aligned to the California Content Standards and Curriculum Frameworks ensuring that our students receive all the necessary tools for their elementary education.

The Saugus Union School District (SUSD) is committed to excellence in elementary education. Our vision, academic and personal success for every child is visible across our 14 individual school sites and each of our program offerings. We strive to ensure that all students receive a rigorous, grade-appropriate academic education and that each has the social emotional tools to ensure success in the world. Our entire district has been recognized with the distinction as a PLC @ Work Model PLC District (one of three in California) and we were also one of 11 school districts in California and one of 100 nationally to be recognized on the Academic Recovery Scorecard for closing the achievement gap post-pandemic. All of our schools have been recognized as California Distinguished Schools with West Creek Academy and Charles Helmers Elementary receiving recognition in 2023 and Mountainview Elementary, North Park Elementary, Cedar creek Elementary, Plum Canyon Elementary, Rosedell Elementary, and West Creek Academy earning this distinction in 2025. Charles Helmers Elementary and West Creek Academy both received the prestigious PLC @ Work Model School title, Rio Vista and North Park received the PLC @ Work Promising Practices School title, and fourteen schools have been recognized as California Gold Ribbon Schools with five schools having been recognized as National Blue Ribbon Schools. Each of our two Title I schools have been awarded the Title I Academic Achievement Award. SUSD is also in the process of implementing many new facilities projects as part of the Measure EE Bond that was passed by the community in 2014. While there are many completed projects that are included in the Bond, SUSD is currently completing new classroom buildings projects and other school renovation projects occurring over the next year. Some of the finished projects include a new school building at several campuses, the completion of our Edible School Yard garden and kitchen at Cedar creek, and solar and landscaping projects to create net zero environments for energy efficiency. The Saugus Union School District is fortunate to have a community that is committed to its school facilities by supporting Measure EE and the numerous Community Facilities District (CDF) funds that it uses to complete these projects.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

SUSD continues to make progress based on our review of 2025 California School Dashboard and local data. Our 2025 English Language Arts and Math metrics indicate that we are in the "green" status. Our 3rd-6th graders gained percentages in meeting or exceeding English Language Arts and mathematics proficiency as compared to CAASPP scores from the prior school year. Our local reclassification data indicates that 30% of our English learner students are meeting the requirements for reclassification. Our Suspension rates dipped into the "yellow" however we met standard on all local indicators.

According to the 2025 Chronic Absenteeism Dashboard Indicator, our overall student group remained in the "green" status, declining 0.5% from the previous year. All student groups declined or maintained in their Chronic Absenteeism percentage (except for the African American student group). This was a big celebration because our schools have made a concerted effort to focus on attendance. In 2025, we had no student groups in the red districtwide. In 2023, Students with Disabilities at Cedar creek Elementary, English Learners and Socioeconomically Disadvantaged students at Tesoro del Valle Elementary, and our Hispanic students at Skyblue Mesa Elementary fell within the "red" area on the Chronic Absenteeism Dashboard Indicator.

According to the 2025 English Language Arts Dashboard Indicator, our All student group fell within the "green" area, maintaining their progress in ELA. All student groups increased in their progress, with our Filipino, Asian, African American, White, and Two or More Races student groups placed at the very high status in "blue". In 2025, we had no student groups in the "red" area. In 2023, Students with Disabilities at Highlands Elementary, Rosedell Elementary, and Skyblue Mesa Elementary and English Learners at Skyblue Mesa Elementary fell within the "red" area on the 2023 English Language Arts Dashboard Indicator.

According to the 2025 Mathematics Dashboard Indicator, our All student group fell within the "green" showing an increase in achievement, with all student groups showing an increase in DFS. Our African American, Asian, Filipino, and Two or More Races student groups increased achievement and fell within the highest "blue" area and our English Learner student group increased 5.8 DFS and fell within the "green" area. In 2025, we had no student groups in the "red" area districtwide. In 2023, we had no student groups fall within the "red" districtwide or at the school sites.

According to the 2025 English Learner Progress Dashboard Indicator, our English Learners increased their progress by 7.1%, placing them in the "green" area. Local data indicates that we were able to increase our reclassification percentage with 30% of our English Learners meeting reclassification criteria.

32.67% of our English learners achieved an overall score of 4 on the ELPAC in 2024-25 (an increase of 8.14%) and almost 60% of our English learners are making progress toward English language proficiency (an increase of 7.1% from the prior year).

According to the 2025 Suspension Dashboard Indicator, 5 student groups fell into "blue" status and 3 groups fell within the "green" status. African American, Socioeconomically Disadvantaged, and White student groups fell within the "orange" status. We had no student groups in the red districtwide or at the school sites.

The February 2026 Basic Phonics Skills Test (BPST) results indicate that 77% of Kindergarteners, 92% of first graders, and 88% of second graders are demonstrating proficiency with the foundational reading skills necessary for their grade level. Our first graders are showing a 10% increase from the previous year while our Kindergarten and second grade students are showing a decrease from the prior year.

Local Indicators have been met in all areas. These areas include the Basics: Teacher assignment, textbook availability, and facilities condition, Implementation of Academic Standards, Parent and Family Engagement, Climate Survey, and Access to Broad Course of Study. Each of these areas continues to be important to the success of our students despite our meeting the expectations for the Dashboard. SUSD will continue working to provide a quality school environment, implement a rigorous standards-aligned curriculum, and engage the parents and stakeholders to create a positive school setting.

Our local connectedness survey data for 2026 indicates that our mental health supports, behavior supports, and intentional actions to engage students in learning within their school community are proving effective. 69% of our students indicated they like school (4% increase), 77% indicated that they feel safe at school (4% increase), and 73% indicated that they feel a sense of belonging and important at school (4% increase).

SUSD plans to maintain our successes through continued professional development in the areas of early literacy for our K-2 teachers and reading comprehension for our 3rd-6th grade teachers, continued professional development around evidenced-based practices for our English learners including our Long Term English Learners, continued monitoring of our English learners academic achievement and language acquisition, and continued support from our Teachers on Special Assignment who will provide in-class coaching for teachers, provide resources and coaching support to our teacher teams, and support grade level teams through the Professional Learning Community processes and practices. We will also continue to support all teachers through professional development in the area of mathematics and writing instruction to support written expression across all content areas.

Learning Recovery and Emergency Block Grant

SUSD has unexpended Learning Recovery Education Block Grant (LREBG) funding and plans to expend the remaining LREBG funding within the 2026-2027 and 2027-2028 LCAP.

LREBG will be funding the following actions in the LCAP for 2026-2027: Goal 1, Actions 1, 2, and 4.

The SUSD needs assessment substantiated findings from the 2025 Dashboard and local data related to the academic performance of students in ELA and Math. A review of state and local data indicates that the ELA and Math academic performance of Students with Disabilities and English Learners is significantly behind other student groups at some of our schools. Based on this analysis, Goal 1, Actions 1, 2, and 4 directly address the need to close the achievement gap for these student groups as they focus on data-driven Professional Learning Communities (PLCs) for accelerated learning. Educators will utilize evidence-based PLC protocols to analyze real-time student assessment data, specifically identifying learning gaps among their students with a focus on English Learners and Students with Disabilities. Teams will collaboratively design, deploy, and monitor targeted, tier-1 and 2 academic interventions and extension strategies. LREBG funds will support this action by financing teacher release time, professional development in data-driven PLC frameworks, and evidence-based collaboration resources. Research supports that school systems who use a cycle of inquiry in addressing student needs and reducing student challenges see more positive progress than those that do not (DuFour, DuFour, Eaker, Many, & Mattos, 2016).

The SUSD needs assessment did not identify significant needs in the area of Chronic Absenteeism.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

Educational Partners were notified through Parent Square and other media platforms that the 2026-2027 LCAP document, along with the input from PAC and DELAC including

written responses from the superintendent's designee, was available for review on the district website with information about sharing their input regarding the LCAP actions and expenditures if they could not attend the public hearing.

Survey data from students, families, and employees, along with academic achievement assessment data, and anecdotal data from staff/parents indicated that the goals for the 2024-2027 LCAP should remain the same as well as most actions in the LCAP to ensure that the goals listed will meet the intended outcomes as the data and evidence demonstrates that the actions are proving effective.

The following is the feedback and input that influenced the actions within the 2026-2027 LCAP:

Goal 1: Closing the Achievement Gap

Feedback from educational partners influenced the LCAP by reiterating the important impact that the Teachers on Special Assignment have on instructional pedagogy in the areas of math and reading and meeting the unique needs of our EL, FY, and LI students (Goal 1, Actions 1-2). There was a plethora of feedback that discussed the need to continue support for the implementation of evidenced-based foundational literacy skills instruction, support for providing reading intervention for upper grade students, as well as continued support with implementation of high-leverage writing strategies. There was also multiple mentions of specific support for staff on implementation of the new math curriculum and support for the instructional shifts that will be required with the new curriculum that also align to the updated math framework. Additionally, feedback also indicated the positive impact that the PLC process has had on student learning and professional learning teams (PLTs) and that the support for PLCs should continue (Goal 1, Action 4). Providing specific funding to the school sites to meet the unique needs of their student groups was also lauded as an important action to maintain (Goal 1, Actions 5-6).

Goal 2: Supporting Academic and Language Needs of English Learners

Feedback from educational partners influenced the LCAP for this goal by stating the importance of maintaining the specific action around the needs of our Long Term English Learners (LTEL), knowing how important it is to support their progress toward reclassification, given their performance data on the 2025 Dashboard. While we saw an increase in achievement for this student group and our English learners as a whole, we want to keep the support to prevent English Learners from becoming identified as an LTEL. Student goal setting was seen as a valuable action and continues to be written within the LCAP (Goal 2, Action 6). Families also indicated that they appreciated the varied workshops available for them (ELPAC, i-Ready, Math Nights, Literacy Nights, Bilingual Storytime, etc) and would like these to continue.

Goal 3: Increasing Student Engagement

Feedback from all educational partners that influenced the LCAP included maintaining a social worker at every school site as their support has been valuable for both students and their families. Families also shared that they would like more opportunities to learn how to best support their own children with challenging behaviors and strengthening executive functioning skills from the social workers and BCBA's (Actions 2 & 5). The input from staff and families also indicated a need for increasing engagement and connectedness to school for some of our students who are exhibiting a skills-deficit in the area of executive functioning, social emotional learning, or self-regulation which impacts their ability to appropriately engage or connect to learning and school (Action 3). While no LCFF funding is being added to this action, additional implementation of current strategies and resources is being explored in relation to this action in order to support students who are struggling to connect and engage in school, academically and/or behaviorally. Input from all educational partners indicated that the new Social Emotional Curriculum that was adopted in 2025 is very effective and both parents and staff would like to continue with its implementation (Action 1) as these resources best meet the unique needs of our current students, with a focus on our EL, LI, and FY students.

Goal 4: Family Engagement and Basic Core Services

Feedback from educational partners resoundingly indicated that our Family and Community Liaisons are a tremendous support and should continue their outreach with our unduplicated count families. They appreciated all of the workshops offered to families this year as well as the parent education institutes (PIQE) and would appreciate even more opportunities to learn strategies to help support their own students at home. Many families and staff also indicated the need for more outreach so that more families can attend the workshops and know about the resources and supports available to them (Goal 4, Action 5). As a result of this input, we are maintaining our 6 members of the Family and Community Liaison team who will be able to help our district increase our outreach and connectedness with more families with a focus on our EL, LI, and FY families.

Goal 5: Equity and Inclusivity for All Students and Families

Feedback from educational partners indicated that we should continue with multicultural events and cultural proficiency training for staff and families and continue to provide additional opportunities throughout students' experiences at school that support students in feeling proud from where they come as well as opportunities for families, staff, and students to share about their own family cultures, experiences, and celebrations (Goal 5, Actions 1-5).

This goal allows us to focus on the programs, practices and activities that will address the individual learning needs of unduplicated pupils (UDP) and address learning gaps we see within our data. We are still seeing a gap between the academic achievement of our unduplicated count pupils and the "All" student groups. Feedback from educational partners indicated that a goal that focused on increasing supports and resources in order for all student groups to achieve at high levels with a focus on our English learners, Foster Youth, and Low Income students was important.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Saugus Union continued to provide services from the 2025-2026 LCAP using supplemental funds identified for implementing instructional programs and services for all students to achieve while also closing the achievement gap.

We were able to implement the actions set forth in the plan, supporting our growth toward our year 2 metric data for Goal 1 and making improvements toward our goal through the actions laid out.

1) The overall implementation of these actions for:

Goal # 1 was fully implemented.

8 of 8 actions were implemented fully

2) The most successful aspects of our implementation of these actions have been:

- Actions 1-3: Our TOSAs provided workshops for teachers in areas of early literacy, number talks, the new math framework, NGSS lesson design, educational technology, writing, and 21st century through after school workshops, summer professional development opportunities, Professional Learning Communities (PLC) team collaboration time, and in-classroom coaching sessions.

- Action 4: The assessment systems supported grade level teams in having actionable, current, and relevant data they can utilize in order to make specific decisions on how to best support our students overall as well as focus on the academic needs of our unduplicated count students and student groups that displayed an achievement gap in the data.

- Action 5: As part of our PLC process, Saugus Union committed to create weekly grade level collaboration time during the school day for grade level teams to analyze common formative assessment data, create action plans for students requiring additional support and time to meet grade level promise standards, and allow for grade level colleagues to share best practices with one another based on their formative grade level data.

- Actions 6 & 7: Unduplicated Count students also benefited from the resources available to them at the site level such as increased opportunities for small group instruction, increased opportunities for teacher teams to analyze data and create action plans for specific students, and an increase in specific professional development based on site specific student needs.

- Action 8: All K-6 students were provided access to technology and having Chromebooks available for UDP students to check out for homework use.

3) The most challenging aspects of our implementation of these actions have been:

We were able to implement all of the actions. While Action 1 identified an additional focus on certain student groups at specific sites, there were times where we supplemented that support through different evidenced-based strategies outside of LCAP actions.

4) There were no planned actions that differed substantively from how it was described in the adopted LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were some material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services. We spent more than planned on our ELA TOSA action (Goal 1, Action 1) due to an increase in professional development that we held for foundational literacy skills based on employee response and demand which means more teachers were trained and implementing causing this to be an effective action. We spent more than planned on our Math TOSA action (Goal 1, Action 2) due to an increase in professional development for all teachers to receive training on the updated Math Framework and the professional development that aligned with our math pilot curriculum. We spent less on the 21st Century TOSA action (Goal 1, Action 3) because we had a third position that we did not fill as this person moved to a coordinator role in our district. The two current TOSAs supported the action. The Assessment Coordinator position (Goal 1, Action 4) was vacant for some of the time so we spent a little less than anticipated. There was more funding expended on the Professional Learning Community (PLC) action (Goal 1, Action 5) as we utilized additional one time funds to provide an increase in professional development in PLC practices and effective instructional practices. Also, the cost for guest teachers to help monitor PE instruction that allowed for grade level teams to focus on PLC actions and processes together on a weekly basis was higher than originally anticipated. Our Goal 1, Actions 6-7 was effective, but the challenge of funding did not align with the original budget in that some of the staff resources were more costly than originally planned for which then reduced how much sites could spend on their supplies.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

According to various metrics within Goal 1, many of our student groups made significant growth demonstrating effectiveness of the actions. According to the 2025 California Dashboard English Language Arts Indicator, all student groups saw an increase in their Distance from Standard (DFS), including all of our unduplicated count student groups (EL, Low Income, and Foster Youth). All students increased by 7.6 DFS, English learners increased by 13.6 DFS, low income students increased by 8.1 DFS, and Foster Youth students increased by 9.6 DFS. This growth indicates that we are on our way to closing the achievement gap.

According to the 2025 California Dashboard Mathematic Indicator, almost all student groups saw an increase in their Distance from Standard (DFS), including most of our unduplicated count student groups. All students increased by 7.2 DFS, English learners increased by 5.8 DFS, low income students increased by 7.9 DFS, while Foster Youth students decreased by 21.5 DFS. This overall growth indicates that we are on our way to closing the achievement gap in Math and we are already working with our Foster Youth students to provide a wraparound, more comprehensive approach to meet their academic needs in Math.

The actions within Goal 1 contributed to academic growth at the local level as explained below. The Teachers on Special Assignment (TOSAs) continue to be effective in supporting teachers to implement evidence-based practices within the classroom to enhance student learning. The English Language Arts (ELA) TOSAs (Action 1) were effective as they continued to engage teachers in The Science of Reading strategies, including Phonological Awareness instruction and writing strategies instruction across content areas. They provided Orton-Gillingham (OG) training to over 80 General Education, Resource, and Special Education teachers (90 hours of certified training in all). Training occurred both in the summer and throughout the school year. Training also included supporting our TK teachers in OG strategies as part of their work day has them providing small group intervention in reading for grades 1 and 2. As of Spring 2026, all TK-6 teachers are officially certified OG teachers. Our current 1st and 2nd-grade students demonstrated mastery of mid-year grade level foundational skills with 96% and 92% accuracy, respectively. 84% of our Kindergarten students are demonstrating mastery in mid-year grade level foundational skills. While our percentages dipped slightly in Kindergarten from this time in the previous year, our K-2 teams continue to gain clarity around the skills students must master by the end of the year and teachers have deepened their analysis of data and intensified their response to the data by developing small group instruction for students designed to target specific needs.

The ELA TOSAs also provided professional development and support for teachers in utilizing our state-adopted core materials aligned to the ELA/ELD framework and in using assessments as both formative and summative tools to gauge students' level of understanding and mastery related to key ELA standards. The TOSAs visited almost 200 classrooms for modeling lessons and coaching teachers. They also met with grade-level teams to help analyze data and create intervention plans. ELA TOSAs created weekly lessons for grades TK-3 that are available on our ELA Literacy Hub and focused on phonological awareness, phonics, grammar, sight words, writing, vocabulary, syllabication, and reading comprehension. They also provided professional development for over 70 teachers in grades K-6 focused on Writing for Student Achievement to build the skill set of all teachers in utilizing strategies to support our students in writing across all content areas. In total, the TOSAs provided 49 professional development sessions. The ELA TOSAs also work closely with site administrators and their site-level Student Study Teams. They trained all K-2 teachers in administering the one-on-one universal reading for difficulties screener (Multitudes) with all K-2 students in order to identify students who may struggle with reading to help target which specific skills students may require prevention and/or intervention support.

The Math TOSAs (Action 2) were effective as they visited over 320 classrooms within all 14 schools and provided professional development on a variety of topics such as math routines to support the math practices, problem solving strategies, writing in math, as well as providing additional professional learning on the shifts in mathematics instruction outlined in the newly adopted California Math Framework during summer and after school workshops as well as grade level specific workshops for ALL teachers (K-6) focused on effective Tier 1 instruction of our Math Promise Standards. These workshops focused on the shifts in math instruction embedded within the updated Math Framework, specific instructional moves to effectively teach our identified Promise Standards, and specific resources for providing intervention and support in these areas. After each grade level workshop, they followed-up using a co-teaching/modeling format to support implementation in the classroom. They also supported upper grade teachers in implementing and practicing writing in mathematics to support performance tasks. They provided on-going professional learning for teachers through staff meetings, collaborative planning time, and grade level team time in the areas of Professional Learning Communities, assessments, performance tasks, Number Talks, and Structuring Numbers, to name a few. The Math TOSAs presented at multiple Parent Engagement events. Their supportive approach focused on many angles such as classroom coaching, just-in-time intervention support, after school professional development, in-classroom demonstrations, as well as investigative work into student engagement has increased teacher awareness and confidence in

teaching mathematics through the lens of Big Ideas. Lastly, the Math TOSAs facilitated the entire math curriculum adoption process, taking a group of 56 pilot teachers from start to finish through the rigorous process of reviewing materials, selecting two curricula to pilot, and then recommending one program to the Governing Board for approval.

The 21st Century Learning TOSAs (Action 3) played a pivotal role in advancing the academic achievement and engagement of students across the Saugus Union School District. This year, TOSAs continued to support implementation of the adopted ELA, Math, and Science curriculum through coaching cycles, lesson modeling, and professional development, including over 100 classroom visits and more than 30 hours of direct teacher support. TOSAs facilitated districtwide professional learning on the Next Generation Science Standards (NGSS), supporting hands-on, inquiry-based learning using district-adopted materials. Based on 2025 CAST data, they supported specific grade level teams across 8 schools with more in-depth in-classroom coaching, modeling, and lesson design for grade level science instruction. Furthermore, they designed and modeled lessons around our cultural celebrations that are grade level, standards-aligned for all grades K-6. They organized and led over 10 different parent engagement events linking curriculum and cultural awareness, fostering stronger home-school connections as well as linking science curriculum to at-home engaging activities. These events were some of the most well-attended events we held this school year.

These collective efforts supported progress toward LCAP Goals 2 and 5 by narrowing achievement gaps, particularly for English Learners, students from low income households, and Students with Disabilities, and promoting inclusive, culturally relevant learning experiences for all students.

The Professional Learning Communities activities (Action 5) continued to be effective as it provided opportunities for grade level teams and school sites to review and analyze current student data and use that data to plan lessons and instruction in response to student needs. Part of our assessment system (Action 4) also included resources such as i-Ready which allowed for our students to have an individual pathway with lessons that are targeted specifically to their needs based on the results of each diagnostic assessment. All students in SUSD have access to Chromebooks (Action 8) to work on their individual pathway each week, providing them additional opportunities to receive targeted instruction and skills practice. As of April 2026, our students have an average of an 85% passage rate on their individual pathway lessons in Reading and an average of 97% passage rate in Math. i-Ready diagnostic results were analyzed by grade level teams to create groups for small group instruction on targeted skills. Students who were identified as working below two or more grade levels and students working one grade level below participated in small group instruction that focused on specific skills. School sites were also able to utilize the specific site allocated funding they received for staff and resources in order to meet the unique needs of their unduplicated student groups (Actions 6 and 7) and many schools saw increases in these student groups' attendance and academic performance based on local data.

In 2024-2025, the final i-Ready Reading diagnostic indicated that 8% of our students were two or more grade levels below in reading, closing the gap from the beginning of the year where 19% of students were reading at two or more grade levels below their current grade. During this current school year, the percentage of students who were identified as below two or more grade levels in reading decreased from 18% in August to 11% in February. This indicates we should see fewer students two or more grade levels below in reading at the end of 2025-2026 when compared to 2024-2025.

In 2024-2025, the final i-Ready Math diagnostic indicated that 6% of our students were two or more grade levels below in math as compared to the 18% that were two or more grade levels below at the start of that school year. During this school year the percentage of students who were identified as below two or more grade levels in Math decreased from 19% in August to 9% in January. Similar to reading, this indicates we should expect to see fewer students two or more grade levels below at the end of 2025-2026 when compared to 2024-2025.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

There are no changes to the goal, metrics, and desired other than we are removing Goal 1, Action 3 (21st Century TOSAs) due to an anticipated reduction in supplemental funds and will support this action through other current staff.

Actions 1, 2, and 4 have been revised to include LREBG funding. Metrics 1.1 and 1.2 already included data for Students with Disabilities and English Learners and will continue to be included.

This goal allows us to place a direct emphasis on the needs of English Learners and their families in order to ensure their general academic success as well as their success in fully developing English as a second language. The Dashboard data indicates that our English Learners are still not achieving at the same level as their English Only peers in both Math and English Language Arts and that only 56.6% of them are making appropriate progress in their language development. Feedback from Educational Partners indicate that having a specific goal focused on our English Learners is important because it keeps their unique language needs at the forefront.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Saugus Union continued to provide services from the 2025-2026 LCAP using supplemental funds identified for ensuring our English learners increase their academic achievement and make appropriate progress toward their acquisition of English.

We were able to implement the actions set forth in the plan, supporting our growth toward our year 3 metric data for Goal 2 and making improvements toward our goal through the actions laid out.

1) The overall implementation of these actions for:

Goal #2 was fully implemented.

6 of 6 actions were implemented fully

2) The most successful aspects of our implementation of these actions have been:

- Action 1: Our Dual Language Immersion program continues to be a success as we expanded the program to have 2 classes K-6. The students and families have continued to share through informal surveys and presentations how much students are learning within the program and the students are making expected academic progress on the internal benchmarks. Our 2025 CAASPP data for our DLI classrooms indicate that students in the DLI program outperformed their English only classrooms at the school site in ELA and Math.
- Action 2: Our site-based ELD Coordinators continued to closely monitor our English learners academic progress and language acquisition throughout the school year using ELlevation as our data resource hub. They supported teachers in providing training regarding Reclassification and using the district-provided available classroom resources intended to support language learners. They also held site-based workshops for parents to learn more about the reclassification criteria and many coordinators held ELPAC workshops for students to have multiple opportunities to engage with practice questions for the ELPAC.
- Action 3: We were able to provide an abundance of resources for our English learners to access grade level content including age-appropriate bilingual dictionaries, i-Pads for translating grade-level materials when necessary, and supplemental resources for both designated and integrated ELD. Parents were also provided workshops in how they can support their children in utilizing these resources.
- Action 4: Initial data indicates that we continue to have more students reclassify this year as well as score a level 4 on the English Language Proficiency Assessments for California (ELPAC). Our classroom teachers, ELD Coordinators, administrators, and the Director of Categorical and Special Programs continued to monitor our English Learners' (EL) academic progress and language development so that all data is reviewed on an on-going basis to determine readiness for reclassification throughout the school year.
- Action 5: We were able to provide targeted professional development for teachers around supporting their English learners throughout the school year. We offered a variety of workshops focused on utilizing state adopted standards-based materials to provide instruction for our ELs as well as provided professional development for a cohort of resource specialists on supporting students who are dually identified. District leadership participated in over 20 total site visits with site administrators focused on EL instruction at all 14 school sites throughout the school year to provide specific feedback on EL instruction and next steps. We hosted a cohort of teachers (at least 1 from every school site) to dive into the ELPAC Interims as an instructional tool which provided clarity for teachers around learning expectations and how to adjust instruction to meet the rigor of the ELPAC assessment.
- Action 6: We successfully held student goal setting conferences, also known as Road to Reclassification Meetings, with all of our Long Term English Learners. Students, families, and teachers stated that this process was uplifting and helped narrow their focus throughout the school year.

3) The most challenging aspects of our implementation of these actions have been:

- Action 5: While we have been providing targeted professional development focused on English Learners, we would like to target more professional development specific to grade level content which we were not able to do yet. We plan to work on this next year as we implement our new math curriculum (supporting English learners in the area of math).

4) There were no planned actions that differed substantively from how it was described in the adopted LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were a few material difference between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services. We expended less funding than originally budgeted for the Site ELD Coordinators (Goal 2, Action 2) as they did not end up needing all of the extra pay hours we had budgeted, most likely due to our use of the ELlevation system which decreases the amount of time ELD coordinators spend on paperwork. We spent slightly more funding on English Learner tools and resources specific to English Learners than anticipated based on the needs of our students (Goal 2, Action 3). The cost for Program Monitoring (Goal 2, Action 4) was slightly less than expected as certain staff did not attend some planned conferences that were budgeted within this role. We spent slightly less than planned for with the ELD professional development (Goal 2, Action 5) as we had less teachers attend some of our workshops than we had budgeted for.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

According to various metrics within Goal 2, many of our student groups made significant growth demonstrating effectiveness of the actions.

According to the 2025 California Dashboard English Language Arts Indicator, English learners increased by 13.6 DFS and on the 2025 California Dashboard Mathematic Indicator, English learners increased by 5.8 DFS. Our reclassification rate increased to 30% and our English Learner Progress Indicator increased by 7.1%.

- Action 1: Our Dual Language Immersion program continues to be a success as we are expanding the program by two classes every year. This year we have Kindergarten through 6th grade. Our 2025 CAASPP data for our DLI classrooms indicate that students in the DLI program outperformed their English only classrooms at the school site in ELA and Math.
- Action 2: Our site-based ELD Coordinators continued to closely monitor our English learners' academic progress and language acquisition throughout the school year using ELlevation. In 2024-2025, we increased our reclassification rate to 30% and over 32% of our students scored a Level 4 on the ELPAC. We also saw our English Learner Progress Indicator increase by 7.1% on the 2025 California Dashboard.
- Action 3: We were able to provide an abundance of resources for our English learners to access grade level content. We also had over 30 families of English Learners request Chromebooks for home use this year, an increase as compared to the previous year.
- Action 4: With the close district level monitoring of students, we were able to reclassify 30% of our English learners and saw over 32% of our students achieve a level 4 on the English Language Proficiency Assessments for California (ELPAC). We also closely monitored students' i-Ready ELA diagnostic and as soon as they demonstrated grade level proficiency we were able to reclassify these students (who met all 4 criteria), allowing us move through the reclassification process throughout the entire school year.
- Action 5: We were able to provide targeted professional development for teachers around supporting their English learners throughout the school year. We increased our offerings to teachers for professional learning including topics around using the ELPAC interims as part of their instruction. We also spent time making teachers aware of the various designated supports and accommodations that are available for students with both the CAASPP and ELPAC assessments. The effectiveness of this action is seen in our 2025 CA Dashboard data for English learners which demonstrates that our English learners had a 13.6 DFS increase in ELA and a 5.8 DFS increase in Math.
- Action 6: We successfully held student goal setting conferences, also known as Road to Reclassification Meetings, with all of our Long Term English Learners. As of this point in the school year, our local data indicates that we have been able to reclassify 10 LTEL students.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Saugus continued to provide services from the 2025-2026 LCAP using supplemental funds identified for creating school environments that are responsive to student and educational partner Social Emotional Learning (SEL) needs to increase their engagement and connectedness to learning and school.

Overall, we were able to implement the actions set forth in the plan, supporting our growth toward our year 3 metric data for Goal 3 and making improvements toward our goal through the actions laid out.

1) The overall implementation of these actions for Goal #3 were implemented.
6 of 6 actions were fully implemented.

2) The most successful aspects of our implementation of these actions have been:

- Action 1: All students in SUSD engaged with social emotional lessons that explicitly taught essential SEL skills necessary for learning, engagement, connectedness, and critical thinking using a new curriculum for K-6 (Character Strong) and our current curriculum for TK (Second Step).
- Action 2: Behavior Support Teams supported more students in remaining in a general education setting and increased skill development for coping and communication.
- Action 3: The student connectedness and engagement position focused on providing targeted leadership and support to our School Social Worker team and focused on building capacity of the team itself to be data-responsive while also providing professional development and refining systems based on the various metrics we now have to guide the work (SEL Screener data, PBIS data points, School Social Worker data, etc).
- Action 4: PBIS and School Engagement resources and professional development has resulted in clear behavioral expectations, positive reinforcement for expected behavior and increased fidelity of implementation of PBIS as well as other school engagement and connectedness resources and programs. The connectedness survey data demonstrated 89% of students indicated that there are clear rules and expectations for behavior at school (a 1% increase from the previous year). Additionally, the district-wide tiered fidelity inventory (TFI) for PBIS states that 98% of our district has fully implemented Tier 1.
- Action 5: We continued to deepen and enhance our mental health supports for students. This focus on support, mental health and building relationships has resulted in 87% of students indicating that help from an adult is available when they need it (a 0% increase from the previous year).
- Action 6: The additional school psychologists supported more unduplicated count students with appropriate access to learning opportunities and multi-tiered systems of supports.

3) The most challenging aspects of our implementation of these actions have been:

- Action 3: While our staff has been focused on building systems and foundations to support students with Tier 1, 2, and 3 supports, there are still students who are requiring additional support and more work to ensure our Tiered Systems of Supports are consistent in all spaces for our students.

4) There were no planned actions that differed substantively from how it was described in the adopted LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were a few material difference between budgeted expenditures and estimated actual expenditures. The staffing positions outlined in Goal 3, Action 2 were not filled throughout the entire year and thus the funding was not fully expended for this action. We spent slightly less on Goal 3, Action 3 due to variation in benefits and salaries. We spent slightly more than planned on our supportive resources (Goal 3, Action 4) as we provided additional professional development for staff. The Mental Health Supports (Goal 3, Action 5) were less than planned as there were some positions that were not filled for the entirety of the school year. We paid slightly more for our additional psychologists (Goal 3, Action 6) as we had to support a position with someone from an agency and the cost is higher with that.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Overall, data from Goal 3 indicates the actions are effective. Our official P2 average daily attendance increased to 97.1% (from 96.7%) and we saw a decline in our Chronic Absenteeism Rate. We declined 0.5% for all students, 2.5% for English learners, and 3% for Homeless student group. We slightly increased our low suspension rate by 0.3% and maintained a 0% expulsion rate.

Action 1: SEL Curriculum

SUSD adopted a new SEL curriculum, Character Strong, for K-6 and it was implemented at all 14 school sites. The district's SEL Curriculum Committee provided teachers with a scope and sequence of lessons to use each week of the school year that aligned with the corresponding Capturing Kids' Hearts (CKH) themes. While we saw increases across the board in our 2025 Connectedness Survey results for students responding favorably to "Students treat each other well at my school" and "Students in my class behave so that teachers can teach," we are still at 50% favorability, underscoring a continued need for a systematic approach to supporting students at all three MTSS tiers, academically, socially, and behaviorally.

Action 2: Behavior Support Teams

SUSD implemented site-level, multidisciplinary Behavior Support Teams, including BCBA's, School Social Workers, and School Psychologists, to increase on-campus capacity for addressing student behavior. These teams are composed of familiar providers who deliver consistent, targeted behavioral support. As a result of their work we saw continued declines in Chronic Absenteeism (declined 0.5%) and an increase of 4% in students responding favorably to the question "Students in my class behave so that teachers can teach".

Action 3: School Engagement and Connectedness

This action provided additional staff and vision for building the capacity of our School Social Worker teams as well as supporting each site's team to ensure they have the tools to increase engagement and connectedness for all students. In reviewing our data, we saw an increase in students accessing Tier 1 social emotional supports (100% of all students accessed Tier 1), an increase in students accessing Tier 2 supports (8% as compared to 1% in the previous year), and a decrease in students requiring Tier 3 supports (4% as compared to 5% in the previous year). We also saw an increase in percentage of students responding favorable to the questions about peer respect and positive feedback given but we did see a decline in students responding favorable to the question about liking school.

Action 4: PBIS Professional Development

As we dove deeper into our implementation of PBIS, professional development was provided to our site-based PBIS coaches to ensure that systems were being refined at the site level. In addition, we focused additional professional development in our Capturing Kids' Hearts (CKH) program at all 14 schools sites and hosted optional professional learning for classified staff throughout the district via the CKH Culture Shapers training. Data from the Tiered Fidelity Inventory (TFI) indicates that 98% of our district has fully implemented Tier 1 with fidelity, 94% have implemented Tier 2 with fidelity, and 91% has implemented Tier 3 with fidelity.

Action 5: Mental Health and SEL Supports

This action was fully implemented across all sites, with each school being staffed with a School Social Worker who provides tiered mental health and SEL support. Social Workers use data (attendance, behavior, SEL screeners, and academic performance) to identify and support unduplicated students through small groups and individual counseling, ensuring equitable access to the learning environment. This action is deemed effective by the increase in attendance districtwide and the decrease in Chronic Absenteeism across all students and most student groups. We also saw our all students accessing our Tier 1 supports provided by the Social Worker team and a decrease in students needing Tier 3 supports.

Action 6: Additional School Psychologists

Additional psychologists are supporting unduplicated students through targeted MTSS interventions to ensure access to appropriate learning opportunities and meet individual student needs. This action is deemed effective by examining our MTSS data. We saw an increase in students accessing Tier 1 social emotional supports (100% of all students accessed Tier 1), an increase in students accessing Tier 2 supports (8% as compared to 1% in the previous year), and a decrease in students requiring Tier 3 supports (4% as compared to 5% in the previous year). While we did see a slight decline in students responding favorable to the question about liking school, we have already dove deeper into additional supports to help increase this percentage in the following year.

Saugus continued to provide services from the 2025-2026 LCAP using supplemental funds identified for engaging our families in the decision making process.

We were able to implement the actions set forth in the plan, supporting our growth toward our year 3 metric data for Goal 4 and making improvements toward our goal through the actions laid out.

1) The overall implementation of these actions for:

Goal #4 was fully implemented.

12 of 12 actions were implemented fully

2) The most successful aspects of our implementation of these actions have been

- Actions 1 & 2: We were able to successfully recruit and hire highly qualified certificated and classified staff.
- Action 3: All students had access to textbooks and necessary materials for learning.
- Action 4: We were able to engage in effective two-way communication with our educational partners through the variety of communication tools we utilize, especially with our families who speak a language other than English. A highlight is the use of the Direct Messaging tool within ParentSquare which allows our families and teachers to communicate with one another in the language they feel most comfortable. This year, we documented over 652,000 direct messages with over 9,700 families interacting with our ParentSquare posts.
- Action 5: Our family and community liaisons were able to connect with more families and facilitate additional workshops to meet the unique needs of our families, including supporting Newcomer families, families from low income households, and our families who speak languages other than English.
- Action 6: Students with IEPs were provided appropriate services to help them meet their individualized goals.
- Action 7: All school facilities have been properly maintained in order for all students and staff to experience a safe, healthy, well-maintained, and learning appropriate school environment. Some of our schools saw upgrades in carpets, classroom furniture, and playgrounds this year.
- Action 8: Parent workshops continued to be offered throughout the district to our families and we were able to host both virtual and in-person workshops to meet the needs of our families. We increased the number of workshops offered to our unduplicated families with targeted topics requested by them, we increased participation and attendance in our workshops, and we also continued to see deeper engagement in participation in meetings such as DELAC, ELAC, Site Council, and Coffee with the Principal.
- Action 9: All of our new teachers and teachers new to Saugus Union were appropriately paired up and supported by a mentor who provided individualized coaching, support, and feedback aligned to the California Standards on the Teaching Profession (CSTPs).
- Action 10: School sites had library media specialists to ensure that all students have regular access to library media resources to assist students with print and digital resources for learning during the school day and to provide regular recreational reading resources and/or opportunities to students so they can refine their individual reading skills through their love of reading.
- Action 11: We continued to utilize translation services throughout the year for parent workshops, parent-teacher conferences, and for all of our Board Meetings, District English Learner Advisory Council (DELAC) and Parent Advisory Council (PAC) meetings when necessary for both virtual and in-person sessions. We continued to see an increase in need for additional languages for translation for conferences as well.
- Action 12: Our site-based GATE Coordinators facilitated unique enrichment opportunities for students to have a differentiated learning experience and showcase their knowledge and learning with peers and families.

3) The most challenging aspects of our implementation of these actions have been:

- Action 8: While parent workshops were implemented fully and we saw a significant increase in attendance, one challenge we saw was continuously trying to increase attendance even more from our unduplicated families throughout the district. This continues to be a focus for us to ensure we are reaching as many families as we can.

4) There were no planned actions that differed substantively from how it was described in the adopted LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were a few material difference between budgeted expenditures and estimated actual expenditures. We spent more on highly qualified certificated employees (Action 1) due to the need to hire agency staff for certain positions and they tend to cost more than a district employee. We spent less than anticipated on maintaining highly qualified classified staff (Action 2) due to vacant positions that were not filled for the entirety of the school year. We spent more on communication tools (Action 4) as the cost of some services increased and we spent less than expected on our Family and Community Liaisons (Action 5) due to two vacant positions that went unfilled for a portion of the school year. We spent less than expected on facilities (Action 7) due to materials costing less than anticipated. We did increase our spending on family workshops (Action 8) due to the large demand for additional supports, topics, and engagement opportunities our families requested. We were able to purchase more resources in multiple languages as part of our workshops we offered as well. Our Library Media Specialists cost (Action 10) was higher than planned for as the cost of some salaries and benefits increased and our translation services (Action 11) increased as the demand for multiple languages increased significantly and we had to work with an outside agency to access translation for parent meetings in these languages.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

All 12 actions seemed to have had a collective impact on our parent engagement and providing basic core services for students.

Actions 1, 2, and 3:

Maintaining and hiring highly qualified staff (Actions 1-2) was effective because it provided our students quality employees. We had 13 misassignments this year however this was specific to the English Learner authorization missing with some of our visiting teachers from Spain in our Dual Language Immersion program and with a few teachers in our Moderate/Severe classrooms. 100% of our students were certified as having access to standards-based materials (Action 3).

Action 4:

The use of our parent communication tools such as ParentSquare continued to be a vital piece in increasing school-home-school communication with our families. These communication tools provided our parents, specifically parents of our unduplicated students (English Learners, Foster Youth, and Low-Income students) with regular two-way communication to increase engagement, increase accessibility, and simplify communication through a common platform with the school environment. As of April 27, 2026, our families and staff have sent over 652,000 direct messages with over 9,700 parents interacting with our posts. ParentSquare data also indicates that over 7,100 families have volunteered at various school events. Families receive and send information in a language of their choosing which has also increased communication with our families who speak a language other than English.

Actions 5 & 8:

The Family and Community Liaisons have also been extremely effective at increasing parental engagement in decision-making. This year our family and community liaison outreach to our families supported an increase of families attending our districtwide and school-wide family workshops and over 40 families participating in our adult ESL classes offered through a partnership with Golden Oak Adult Education School. We also had over 110 parents participate in the Parent Institute for Quality Education (PIQE) series supported by our family and community liaisons. Many of the families who participated in the PIQE workshops also have been attending additional workshops and meetings including site council, ELAC, and DELAC meetings, and participated in Family Literacy workshops held at the school site. Our family and community liaisons have also facilitated numerous parent workshops throughout our district, providing families with essential tools to support the academic and social emotional growth of their children and also create community within the parents/guardians themselves. Our family and community liaisons have also supported over 1,000 families with registering for our expanded learning opportunities programs including after school enrichment, after school programming, and summer STEAM camp opportunities. Qualitative data indicates that many parents who have participated in various workshops have expressed gratitude for the opportunities but also have seen the impact gaining this knowledge has had on their students. They shared that they feel more confident speaking to a teacher, more prepared in attending conferences, and empowered to share their voice.

Action 6:

Services for students in special education were provided to students with Individualized Education Plans and the impact was evidenced in our 2025 CA Dashboard data with this student group seeing an increase of 10.9 DFS points on the ELA indicator and an increase of 10.6 DFS points on the Math indicator.

Action 7:

All of our facilities were considered in "good" repair according to the Facilities Inspection Tool which ensured our students and staff had access to safe and clean learning environments.

Action 9:

All of our new teachers and teachers new to Saugus were provided with a teacher mentor who provided coaching within the classroom environment as well support with lesson design, implementation of our district pacing guide, and analysis of student data.

Action 10:

All students at each of our 14 schools had access to a library media specialist and engaged in a variety of literary activities and exposure to new authors and genres.

Action 11:

We saw an increase in families requesting translation during parent conferences and we were able to offer translation for additional languages that were requested. Families utilized this resource at Board Meetings and parent workshops in addition to the parent-teacher conference opportunities.

Action 12:

This year we screened students for giftedness by request from teacher or parent which allowed for gifted students to be identified and staff was therefore able to provide support and instructions to meet their unique needs.

Our greatest highlight within this goal is found within our local connectedness survey data. We saw an increase in families' favorable responses in 6 out of 12 areas and the 6 out of 12 remaining at the same percentage as the previous year (all at or above 90%). Of the over 5,900 families that participated (64% of our student enrollment), 94% of families indicated that they feel they have many opportunities for family engagement. In focusing on school connectedness and safety, 93% of families indicated that their children like school, 88% indicated that their children receive positive feedback at school, and 92% indicated that their children feel safe at school.

This goal allows us to create a culturally responsive school environment where all students "see themselves" within the school culture, within the school curriculum, and they develop the resiliency needed to be successful in the world. Because of the work being done to close the achievement gap, it was critical that the district emphasize the unique needs of all students and continue to examine the manner in which the district creates inclusive, culturally proficient environments for learning. The data from the Connectedness Survey indicates that this was a high priority as many students do not see themselves in their schools or feel like they are a valued member of the community. This goal was supported by the feedback from our Educational Partners and sets specific metrics and outlined actions/services to support the success of the district in these areas.

Goal Analysis for 2025-2026

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Saugus Union continued to provide services from the 2025-2026 LCAP using supplemental funds identified for providing opportunities for staff and students to see themselves represented in our schools.

We were able to implement the actions set forth in the plan, supporting our growth toward our year 3 metric data for Goal 5 and making improvements toward our goal through the actions laid out.

All actions in Goal 5 were implemented.

1) The overall implementation of these actions for:

Goal # 5 was mostly implemented.

4 of 5 actions were implemented fully

1 of 5 actions was partially implemented.

2) The most successful aspects of our implementation of these actions have been:

- Action 1: Our 21st Century TOSAs provided professional development opportunities for certificated staff so they could have grade level specific lessons aligned to the grade level standards with a focus on cultural proficiency, equity, and diversity. These lessons were pushed out monthly to our teaching staff and aligned with our board-approved cultural celebrations.

- Action 2: We provided classrooms and libraries with supplemental resources (i.e. literature, non-fiction, primary sources, videos, etc.) related to the various student groups represented in our school community to ensure that our students from traditionally underrepresented groups had access to positive depictions of their culture, gender, race.

- Action 3: We provided additional professional development workshops and grade-appropriate supplemental resources aligned to the CA Content Standards and Subject Area Frameworks in order to support our teachers with the skills and strategies to fully include culturally sensitive content during California standards-aligned lessons.

- Action 4: Our families were provided resources and information around culturally sensitive content through Coffee with the Principal meetings and workshops as well as multicultural and multilingual events that were held at individual school sites and districtwide. These opportunities continued to be well received.

- Action 5: We began our outreach with families to be a part of our Parent and Educator Advisory Coalition for Engagement (PEACE) group this year. This process included working with 3 site principals and identified parents who were willing to meet and discuss their unique stories and experiences in Saugus Union and in the Santa Clarita Valley.

3) The most challenging aspects of our implementation of these actions have been:

- Action 5: This year we focused on a reboot of our PEACE committee. Our Assistant Superintendent of Education Services individually met with over 50 families across three schools (all of whom were families of students of color). These individual meetings were held in order to gain a deeper understanding of their child's and family experiences in our schools, and gathering their feedback to provide an opportunity for them to be seen and heard and discuss any current issues or problems that we could collaborate around together. While we attempted to invite these parents to be a part of the Parent and Educator Advisory Coalition for Engagement (PEACE) meetings, we did not get the opportunity to bring everyone together by the time our individual meetings concluded. We plan to work with these individuals in the 2026-2027 school year as meet them as a PEACE committee.

4) There were no planned actions that differed substantively from how it was described in the adopted LCAP.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There are some material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services. We spent less than anticipated for professional development as we used funds from Goal 1, Action 5 as the purpose overlapped. We spent slightly more on Goal 5, Action 2 since we purchased additional literary resources for our classrooms. We spent less on professional development opportunities within this goal and action as we used funds from Goal 1, Action 5.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The collective efforts of the 5 actions within Goal 5 can be determined as effective when looking at the 2025 CA Dashboard ELA and Math indicators as well as the 2026 local connectedness survey data.

According to the 2025 California Dashboard English Language Arts Indicator, we had many of our student groups make gains, including our English learners (+ 13.6 DFS), Foster Youth (+9.6 DFS), Hispanic/Latino student group (+8.6 DFS), African American student group (+26.5 DFS) and Asian student group (+6.1 DFS).

According to the 2025 California Dashboard Mathematics Indicator, we saw gains with our English learners (+ 5.8 DFS), Asian student group (+10 DFS), Hispanic/Latino student group (+7.4 DFS), African American (+19.3 DFS), and Two or More Races student group (+3.5 DFS).

According to our local connectedness data, we saw students' favorability responses increase significantly in connectedness to school and feels of seeing themselves within their learning. Overall, 73% of our students indicated they felt included and had a sense of belonging within the school community. 73% of our English learners and 72% of our students from low income households indicated that they felt included and had a sense of belonging. 55% of our students indicated that they saw their culture represented within their learning and curriculum (a 1% increase). When breaking this down by student group, we saw that 68% of English learners and 57% of students from low income households indicated that they saw their culture represented within their learning this year, a 6% increase and 4% decrease respectively. We plan to conduct focus groups to determine what ideas students have about having their culture represented throughout their learning.

The Teachers on Special Assignment (TOSA)s continue to be effective in supporting teachers to implement evidence based practices within the classroom to enhance student learning and providing supplemental resources related to the various student groups represented in our school communities to teachers and students in the classroom (Action 2).

Our 21st Century TOSAs continued to provide professional development on incorporating cultural celebrations into the classroom (Actions 1 and 3), including a focus on connecting grade level content that focuses on cultural celebrations and the various race/ethnicities represented in our curriculum with the visual and performing arts standards. They also designed lessons and culled resources for teachers that focused on embedding an equity lens within content instruction. They facilitated multiple parent engagement workshops (Action 4) linking the work they are doing around cultural celebrations and cultural proficiency with family engagement. Some of our events were filled to capacity with a waitlist to attend. Parent and Educator Advisory Coalition for Engagement (PEACE) workshops (Action 5) was deemed partially effective as we held individual meetings with over 50 families of students of color to hear their perspective and experiences in our schools but we did not have the opportunity to bring them together collectively this year as a group.

There are no planned changes to the goal, metrics, target outcomes, or actions for the coming year. We did not include specific funding for Actions 3-5 as these actions are intertwined through funding in other goals and actions (i.e. Goal 1, Actions 1-2 and Goal 4, Action 8) however the actions themselves will remain as they are important and evidence shows they are helping us achieve metrics within Goal 5.
