1. General Statement of Assurances

Mr. Yoder explained that action items 1-3 have no changes to our authorized employees, Superintendent, Business Manager, or Governing Board Members from FY 25 going into FY 26.

Mrs. Conner made a motion to approve all current authorized employees in positions for items 1 & 3 to continue in that position for FY 26 as well as approving the Superintendent, Business Manager, and Governing Board members to retain current responsibilities for action item 2. 2nd by President Skousen. Passed 3-0.

- 7. 1GPA
 - Mr. Yoder stated that the MESC (Mohave), Omnia, and 1GPA are the cooperative purchasing contracts that we are currently using. We also have purchasing agreements with the state that provide additional resources and tools for the district. He recommended continuing our current agreement and contracts.
 - -President Skousen made a motion to approve the use of all state and cooperative purchasing contracts listed in items 4-7. 2nd by Mr. John. passed 3-0
- 8. Board Resolution for Payroll Garnishment Mr. Yoder stated this is agreement allows the district to do wage garnishments that are requested through Maricopa County.
 President Skousen made a motion to approve the Payroll Garnishment authorization if submitted to the district from Maricopa County. 2nd by Mr. John. passed 3-0
- 9. Board Resolution (No Site Council)
 - a. Tax Tuition Credit

- Mrs. Conner made a motion to continue not having a site council due to our size and to authorize Mr. Yoder as the Principal of Sentinel Elementary to utilize the tax tuition undesignated monies at his discretion and based on his priorities in accordance with the guidelines listed the state statute. The motion includes assessing a reasonable fee to students for extracurricular activities that can be waived at the discretion of Mr. Yoder. This will allow Mr. Yoder to use the tax tuition monies for the extracurricular fee. 2nd by President Skousen. Passed 3-0
- 10. Sole Source Fuel Purchase Mr. Yoder stated that Conde's Enterprises is the only local fuel source for our buses and that Chevron/Gila Bend Foot Mart offers a discount to the district for fuel in Gila Bend where our bus stop is. Each accepts our Voyager Fleet Cards. Mr. Yoder recommends continuing to grant sole source status to these two fuel providers due to the lack of other local sources and the discount price of the fuel, which is a cost saver to the district.
 - -Mr. John made a motion to continue Sole Source status for Conde's Enterprises and Chevron/Gila Bend Food Mart as fuel providers for the district buses. 2nd by President Skousen, Passed 3-0.
- 11. Classroom Site Fund \$50,000 in the fund for FY 26. President Skousen made a motion to continue the requirement for teachers receiving the payouts from the funds to remain the same as FY25 for FY 26. 2nd by Mrs. Conner. Passed 3-0
- 12. Student Council Fundraisers President Skousen made a motion to allow the following fundraisers for the Student Council in FY 25:
 - Concessions throughout the year
 - Independence Day Dinner
 - Halloween Dinner and activities
 - Pizza Fundraiser
 - Secret Santa Shop
 - Family Fun Night
 - Track-A-Thon
- 13. Designation of Qualified Evaluator Mr. Yoder has taken the QE training 1 and 2. Mrs. Conner made the motion to approve Mr. Yoder as the authorized Qualified Evaluator for SY 25-26. 2nd by President Skousen. Passed 3-0
- 14. Campus Security Proposals School received three quotes. Paloma Security met the criteria set by the district for its security needs. Mr. John made the motion to approve Paloma Security as the district's security provider. 2nd by Mrs. Conner. Passed 3-0
- 15. Acceptable Use for Internet (CIPA) Mrs. Conner made a motion for the school to continue following the Children's Internet Protection Act. 2nd by Mr. John. passed 3-0
- 16. FY 26 Proposed Budget The proposed budget was signed by the Superintendent, Business Manager, and all three Governing Board member then posted on the school website and linked to the budget office at the Arizona Department of Education. There will be a public hearing and a governing board meeting on July 8, 2025 at 9:00 AM at Sentinel Elementary School to discuss and adopt the FY 26 budget. President Skousen made a motion to approve the proposed FY 26 budget. 2nd by Mr. Yoder. Passed 3-0

17. Sale of Bus 2 and 4 to RWC (\$20,000 and \$3,500) – Mr. Yoder proposed selling Bus #2 and Bus #4 to RWC for the quoted prices of \$20,000 for Bus #2 and \$3,500 for Bus #4. Each bus is adding to our transportation cost and each has had mechanical issues that the district does wish to continue spending money on. Mrs. Conner made a motion to approve the sale of buses #2 and #4 to RWC. 2nd by President Skousen. Passed 3-0
