 - c. If additional funding is needed, notification will be provided at least thirty days prior to the testing date.**
 - d. Report data to the PED by June 30, 2026; including:**
 - i. Number of AP exams taken May 2026;**
 - ii. Number of AP exams that were fee reduced; and**
 - iii. Schools and districts utilizing the AP exam fee reduction process.**
 - e. Establish and implement a method for verifying that the funds were used to support only exams administered to eligible low income students.**
- III.
