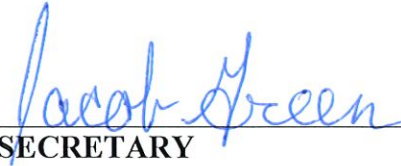
Vice President Culbertson stated no action was taken.

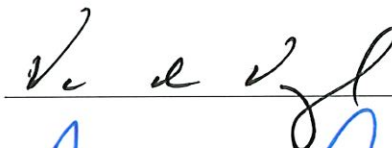

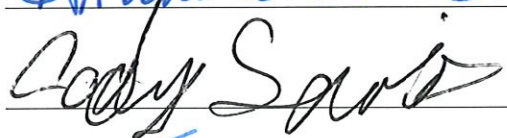

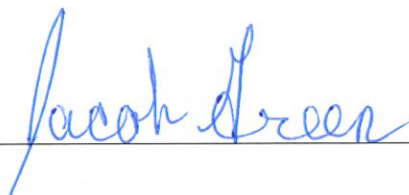
