Superintendent Lobato provided the following updates:

- Dr. Lobato took a moment to introduce Enoch Davis to the Governing Board.
- Mr. Ruiz, Curriculum Director provided a review of the 2021-2022 FESD Learning Platform Parent Survey results. He reviewed the preferences by site along with the data.
- Mr. Ruiz highlighted a recent program our Virtual Academy students were able to participate in with Sierra Linda High School students. The program is titled Remote Integrated Tutoring Education (RITE). The program was created by public health students from the University of Arizona Mel & Enid Zuckerman College of Public Health. Our students were tutored by Sierra Linda High School students, whom had received training from the University of Arizona public health students. Our Virtual Academy teachers provided supervision during the online/virtual tutoring sessions. The district looks forward to the possibility of participating again in the 2021-2022 school year.
- Mr. Stewart provided an overview of an upcoming COVID-19 vaccination event on Monday, June 21, 2021 at Sunridge Elementary School. The focus is to provide an opportunity for our community to get vaccinated. The event is co-sponsored by the Maricopa County Department of Public Health and the University of Arizona Mel & Enid Zuckerman College of Public Health. He provided an English and Spanish flyer regarding the event.
