During this period, errors resulted from staffing shortages, changes, and improper training due to staffing changes within the Accounts Payable staff with coverage and training issues and in reconciling banking statements. She stated that COVID Pandemic issues made conducting school business increasingly challenging. Since then, employees have been appropriately trained, and procedures have been implemented to avoid the reoccurrence of situations resulting in findings. Mr. Ostrom provided an overview and shared that the audit was a learning opportunity for the finance team. The district financials indicated the district was in good standing. Ms. Ulloa stated that Ms. Miller and Mr. Gooden have cross-trained. Under Mr. Ostrom's guidance, Mrs. Miller and Mr. Gooden have implemented and refined procedures to ensure that errors are not repeated.
