Registration Information

The six-week Idaho Driver Education and Training Program is a formal and organized education and training program to introduce and develop good driving habits and attitudes for a lifetime of responsible, reduced-risk driving strategies. Idaho Digital Learning Academy's (IDLA) online course fulfills the requirement of 30 hours of classroom time. The course will be taken on the student's own time (not within the school day). The IDLA course meets national standards for online learning and is approved by the Idaho State Department of Education.

As of July 1, 2024, Idaho Code Section 49-307 will allow students who live in a rural district or a district that does not have a public driver education program to receive behind-the-wheel training from a parent or legal guardian. This is equivalent training to a traditional driver education course. Completion of behind-the-wheel training is the responsibility of the student and parent or legal guardian. Rimrock Jr-Sr High School takes no responsibility for students' completion of the behind-the-wheel training requirements. IDLA Driver's Education is Advanced Opportunities/Fast Forward eligible, which means it will be transcribed on your permanent high school transcript as Pass or Fail.

To enroll in the Driver's Education course, complete the following steps:

- 1. Student must be at least 14 ½ years old.
- 2. Submit the IDLA Student Registration Form (attached) and Advanced Opportunities Participation form to the Rimrock office (if eligible). NOTE: Anyone who is not enrolled as a student at Rimrock will be ineligible for Advanced Opportunities funds, and will have to pay a \$40 IDLA fee (reduced as of Summer 2025) to the Rimrock office. Make checks payable to Rimrock.
- 3. Obtain a Verification of Compliance from the Rimrock office as proof of enrollment at Rimrock (only applicable to Rimrock students).
- 4. Visit your local DMV office to purchase a driving permit. See next page for what documents you will need to provide. Contact your local DMV office if you have questions.
- 5. Return the following to Rimrock to complete enrollment:
 - a. Temporary driver permit stub/receipt (examples provided in this packet)
 - b. IDLA Student Registration Form and Advanced Opportunities Participation Form (if not already submitted)
- 6. Create a student account (Follow Step 1 on "Student Accounts" page).

Students will be registered for a class once all required documents (including driving permit stub/receipt) and payments (if applicable) are received. **IDLA does not guarantee course availability, so course dates cannot be guaranteed until all the above steps are complete and you are registered.** If a course is full, students will be put on a waiting list.
