

**BRUNEAU-GRAND VIEW JOINT SCHOOL DISTRICT NO. 365
OWYHEE COUNTY AND ELMORE COUNTY, STATE OF IDAHO**

**A RESOLUTION CALLING FOR
SCHOOL CLOSURE ELECTION**

WHEREAS, in accordance with Section 33-511(3)(a), Idaho Code, as amended, the Board of Trustees of Bruneau-Grand View Joint School District No. 365, Owyhee County and Elmore County, State of Idaho (the “District”) has determined that it is in the best interests of the District and its students to close Bruneau Elementary School (“BES”), and having also determined that BES had been operated and maintained by the school’s former district now wholly incorporated within the boundaries of the District and, immediately following reorganization and the dissolution of said former district, that BES has been continuously operated and maintained on or about the same location by the District, and having received a timely petition from five (5) or more registered District electors, and has concluded that the election procedures set forth at Section 33-511(3)(a), Idaho Code, should be followed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the District as follows:

- SECTION 1. That a school closure election be and the same is hereby called to be held at designated polling stations on Tuesday, November 4, 2025, for the purpose of submitting to the qualified electors of the District the question set out in the form of the ballot appearing in Section 3 hereof.
- SECTION 2. That the Election Clerks of Owyhee County, Idaho (the “Owyhee County Clerk”) and Elmore County, Idaho (the “Elmore County Clerk”) shall administer and coordinate the election pursuant to and in accordance with Title 34, Idaho Code.
- SECTION 3. That the form of the official ballot will be substantially as follows:

The Board of Trustees of Bruneau-Grand View Joint School District No. 365, Owyhee County and Elmore County, State of Idaho, is seeking authorization to close Bruneau Elementary School, and submits the following question.

QUESTION: Shall the Board of Trustees of Bruneau-Grand View Joint School District No. 365, Owyhee County and Elmore County, State of Idaho, be authorized to permanently close Bruneau Elementary School located at 28541 Benham Road, Bruneau, Idaho?

SECTION 4. That the form of notice of the election shall be substantially as follows:

Notice is hereby given that pursuant to the laws of the State of Idaho and the Resolution of the Board of Trustees of Bruneau-Grand View Joint School District No. 365, Owyhee County and Elmore County, State of Idaho, adopted on August 12, 2025, a School Closure Election will be held on November 4, 2025, between the hours of 8:00 a.m. and 8:00 p.m., at designated polling locations in Owyhee County and Elmore County, for the purpose of voting upon the following question authorizing the closure of Bruneau Elementary School, located at 28541 Benham Road, Bruneau, Idaho, serving families within its attendance area described as Zone 1 - Bruneau Elementary School. *BEGINNING at State Highway 78 (Marsing Murphy Road) and Mormon Boulevard, thence Southerly then Westerly then Southerly along Mormon Boulevard, thence Easterly along Cattle Drive to State Highway 51, thence Southerly along State Highway 51 to Rowland Route Road, thence Southeasterly along Rowland Route Road to South School District Boundary and the Idaho-Nevada Border, thence Easterly then Northerly along School District Boundary to the thread of the Snake River and the Elmore and Owyhee County Line, thence Westerly along the thread of the Snake River to CJ Strike Reservoir then the Snake River along the Elmore and Owyhee County Line, thence Westerly along thread of Snake River to the left bank of the Snake River, thence Westerly from left bank of the Snake River to the Strike Dam Cut-Off Road, thence Southerly along Strike Dam Cut-Off Road to Black Sands Road, thence Westerly along Black Sands Road to River Road, thence Southerly along River Road to Unnamed Drainage, thence Westerly along Unnamed Drainage to State Highway 78 (Marsing Murphy Road), thence Southeasterly along State Highway 78 (Marsing Murphy Road) to Mormon Boulevard and the POINT OF BEGINNING.*

Voting on the question of discontinuing the Bruneau Elementary School will be limited to only qualified school district electors residing within Bruneau-Grand View Joint School District No. 365.

QUESTION: Shall the Board of Trustees of Bruneau-Grand View Joint School District No. 365, Owyhee County and Elmore County, State of Idaho, be authorized to permanently close Bruneau Elementary School located at 28541 Benham Road, Bruneau, Idaho?

(End Form of Notice of Supplemental Levy Election)

SECTION 5. That the Clerk of the Board of Trustees of the District (the "Clerk") is authorized to convey to the Election Clerks of Owyhee County, Idaho (the "Owyhee County Clerk") and Elmore County, Idaho (the "Elmore County Clerk") the forms of the Official Ballot and the Notice of School Closure Election, appearing in Sections 3 and 4 hereof, for election preparation and publication pursuant to Title 34, Idaho Code. The Clerk shall submit these forms to said County Clerks on or prior to August 29, 2025.

SECTION 6. That the County Commissioners of Owyhee County, Idaho and Elmore County, Idaho, shall act as the canvassing board pursuant to and in accordance with Title 34, Idaho Code, and will certify and convey the results to the Board of Trustees of the District as provided therein.

SECTION 7. That if at the election a simple majority of the qualified registered electors of the District authorize the school closure, the closure of Bruneau Elementary School shall be approved and become effective in accordance with the provisions of Section 33-511(3)(a), Idaho Code.
