

# Overview

#### What is the 21<sup>st</sup> CCLC Program?

The 21<sup>st</sup> Century Grant Program is a state funded program designed to provide extended learning and enrichment opportunities to students and parents. This standards based program, which is not offered during the academic school day, allows motivational choices for students to be able to expand their creativity and develop necessary skills toward becoming successful members in our challenging community.

#### How has the 21<sup>st</sup> Century Grant Program been designed with the best interest of students?

Highly qualified, dedicated teachers combined their academic expertise with engaging before/after school activities that students will enjoy. Their reading, writing, and math objectives will also correlate with Arizona State standards.

#### COST

The Program is offered to all students free of cost.

#### **ARRIVAL TIME**

Supervision is not provided before 7:10 a.m. Please make sure that your child does not arrive on the school grounds before 7:10 am if attending the Vikings Club before school. Students must arrive on time. School's gate will close at 7:30 a.m. and it is important to be punctual.

#### PICK UP TIME

Students attending the after school program must be picked up no later than 4:45 pm. Parents must be punctual.

#### **CROSSING GUARDS**

☆ Crossing guard will be stationed at Arizona Avenue in front of the school from 7:10 a.m - 7:20 a.m. The crossing guard is there to help children cross the street safely and students are expected to obey their instructions. A crossing guard on 24<sup>th</sup> Street and Arizona Avenue will not be provided.

#### **BREAKFAST**

☆ Students will be able to have breakfast in the classroom starting at 8:20 a.m.

#### **SNACKS**

A free after school snack will be provided for all registered participants in accordance with USDA guidelines if attending the Vikings Club after school.

#### **SCHOOL TELEPHONE**:

A Parents wishing to leave messages for their children may do so by contacting the office or dialing their Vikings Club teacher's phone number. Children are requested not to use the office phone for calls unless it is an emergency or specifically requested by the teacher or parent. You may also contact your child's before/after school teacher via Class Dojo.

#### GENERAL RULES FOR PARTICIPANTS

☆ Students must adhere to all school rules and procedures as indicated in McGraw's Student Handbook and Yuma School District One's policies and procedures.

#### DRESS CODE

Students must adhere to the school's uniform dress code as indicated in McGraw's Student Handbook.

#### ATTENDANCE

- 3 absences will be acceptable for all students. After the 3<sup>rd</sup> unexcused absence, parents will be contacted by the coordinator to confirm the child will be attending the program.
- ☼ Incentives will be provided for students who have great attendance.

#### **ENROLLMENT STATEMENT**

CW McGraw Vikings Club, 21st Century Community Learning Center, advertises enrollment three times a year (Summer Learning, Fall Session, and Spring Session). Services are provided for students during non-school hours or periods when school is not in session.

Enrollment Period: All enrollment windows include a start and end date. However, CW McGraw Vikings Club may add students through the academic year as needed.

The program enrollment has limited open positions. The program is a Federally Targeted Program funded through a funding formula. Once the total capacity is established, all other enrollment applications will be maintained on a waiting list.

The overall enrollment capacity is established to ensure high-quality academic programming. The program strives for efficient utilization of appropriate instructional program resources and needed accommodations. Individual courses and program enrollment limits ("caps") are determined based on academic need, demands, available physical space (e.g., classroom size), and the need to maintain optimal class sizes for rigorous core academic support in reading, literacy, and math.



The 21st Century program at McGraw maintains the flexibility to make necessary adjustments to capacity (limited enrollment). Late enrollment may include assessment data analysis and staff recommendations for program attendance procedures, as well as program participation recommendations from staff and legal guardians. The 21st Community Learning Centers Site Facilitator and the Administration Team members will communicate the timeline to review the ongoing enrollment process.

Furthermore, the 21st Century Community Learning Centers Site Facilitator will coordinate the necessary program recommendations, such as the need for transportation, integrate multiple disciplines, IEP accommodations, specialized hiring staff in accordance with internal Human Resources policies, i.e., nurse, and additional facilities needed to support program compliance in general for all 21st Century Program Enrollees.

McGraw reserves the right to close enrollment in specific classes (core-enrichment opportunities, community partnership classes) Once the established enrollment capacity is reached. Furthermore, determining the Student/Teacher ratio of 21st CCLC-funded classes, McGraw will evaluate the overall enrollment and maintain focus on reaching the attendee goal by the end of the program year.
